C. B.L.I.N.G Funding Work Session

Inequity we are addressing:

- Lack of young people voting
- Older white people making decisions for SF (data point here)
- Low voter turnout in general (data point here)

Why is it a social justice issue?:

- The effect of the individual vote has the ability to turn into a mass voter turnout
- Donald Trump impact focus-this has huge impact on youth already
- Focus is on change-we want to see youth ready to be engaged civically as well as change the demographics of those who are voting
- Prop F focus-we want youth to be engaged civically and have a say in our city

How will our Project Address the Issue?:

- 1) Presentations:
 - a. To schools (Civic, English, History, Politics, Peer Resource Classes)
 - b. To community orgs (tap into existing relationships with current YC'ers)
 - c. Community Outreach events (table at events in particular communities like the Tenderloin, Mission, Bayview Hunters Point)
 - d. Need flyers and handouts
- 2) Media Campaign:
 - a. FB and Instagram
 - b. Spotify
 - c. YouTube
 - d. Snapchat
- 3) Schwag:
 - a. Pens, stickers, fylers, posters
- 4) Ideas in general:
 - a. Where does SFUSD and Dept of Elections come into play? Need to schedule representatives to come to a CE meeting and talk through this process with them
 - b. School competition of whichever gets the most students to pre reg wins
 - c. Attach pre reg papers to graduation certificates?
 - d. Use a texting app called Hustle to do mass texting
 - e. Prom and putting the pre reg paperwork somewhere there or in paperwork
 - f. Give them pre reg info when they get their school picture taken
 - g. Put something in their student handbook to fill out
 - h. Where does the Driver's License sign up come here (check with Dept of Elections)

The Impact we hope to have on Other Youth:

- Increase voter registration in general
- Increase the number of youth to pre register
- Have youth feel empowered
- · Give youth a voice
- Understand that youth votes matter
- Younger voters are more likely to vote earlier and consistently



- Change the demographics of the voters (decrease amount of older white people and increase youth of color, gender, socio economic etc)
- The local impact on SF-it's an investment in their own community and city
