a. Civic Engagement Survey

Chair Hum, Chair Loftus, and Commissioner Barker Plummer recapped the feedback from the Full Commission meeting for Commissioner Utting. There were concerns around the length of the survey, the purpose, collecting people's citizenship eligibility to vote, the proper language



around gender identity, and whether or not to make more questions for students who may be unable to pre-register to vote.

Commissioner Utting is looking at different SFUSD surveys to look for the proper language for gender identity. Clerk Zhan is helping Commissioner Utting to look for a SFUSD contact to ask questions and possible collaboration. Commissioner Utting will work on adding another section for students who can't preregister to vote.

b. Discussion on Upcoming Resolutions

Chair Hum is working on a resolution around priority for homeless SFUSD families and students and gauging interest from other committee members. Chair Loftus is still working on the sexual assault and harassment in SFUSD resolution and aims to present it at the Jan 3rd Full Youth Commission meeting. Commissioners Barker Plummer and Nguyen have started the draft, and Chair Loftus will work off of that. Chair Hum requested to be added to the document.
