- 6. Committee Business (Discussion)
- A) Civic Engagement Survey Timeline

Commissioner Utting states the original timeline was to have all emails sent tomorrow Jan 20th, and the survey deadline will be Feb 18th. Some of the Commissioners expressed in the Full Commission meeting that they want to have the deadline extended. Commissioner Barker Plummer agrees with extending it. The minimum responses desired is about 500 responses. Chair Hum suggests the survey is open for two months. Commissioner Barker Plummer adds that the Commission might need to have multiple rounds of promotions. Commissioner Utting agrees but suggests keeping the original deadline on the survey to encourage urgency and



people filling it out earlier. If by Feb 18th, the Committee hasn't reached the desired goal, then the Committee will extend it and reevaluate the promotion strategy. Commissioner Barker Plummer agrees.

B) Discussion on Upcoming Resolutions

Commissioners Hum and Pimentel will be working on a mental health resolution. Commissioner Barker Plummer will be working more on the Sexual Harassment and Assault resolution, and he added sponsors and cosponsors. He's looking at different curricula for data. Commissioner Im emailed the SFUSD Equity Office for data, and the office is compiling the data. Staff and Commissioner Barker Plummer will follow up with the Office of SHARP regarding the resolution on SA/SH. Commissioner Utting suggests making a resolution of Civic Engagement Day for Youth or City Hall Open House. Staff said that there is old data in the office from one agency, so she'll start there and look for departments that work on civic engagement in youth.

The Committee reviewed the data and drafts of all the Civic Engagement and Education Committee BPPs and provided feedback. The Commissioners will send staff a list of questions to send to various departments.
