Recovery Hubs



What are Recovery Hubs?

- One-stop resource center for neighborhoods
- 4 locations in different neighborhoods: Mission,
 Excelsior, Bayview-Hunters Point and Visitacion Valley
- Currently serving
 - 12,000 low-income and marginalized clients annually
 - 80% are immigrants
 - 60% are undocumented

Core Areas

- Basic needs and service navigation
- Extended education and childcare
- Employment
- Housing

Basic Needs

Includes access to

- Food
- Clothing
- Health care
- Assistance with public benefits

- Immigration legal assistance
- Emergency aid to fire victims and other families in crisis

Extended Education and Childcare

Includes

- Free, low-barrier after-school academic support
- Programs during summer, winter and spring break with extended hours
 - 100% low income
 - 40% living in transitional housing/shelters
 - 88% newcomers
- Education enhancements (ie. ESL and computer skills) for students behind academically
- School readiness supplies for newcomer students

Housing

Includes

- Obtaining housing through the city's DAHLIA system
 - 939 clients apply for housing
- Rent relief
 - Secured \$1,265,687 for 200 clients,
- Subsidies for rent, deposits, and utilities
- Rehousing and eviction assistance
 - 69 households have been placed in permanent housing

Employment

Includes

- Specialized assistance for undocumented job seekers
 - 70% of our employment clients
- Job placement and access to employment training, including Latino Task Force's training in janitorial and TDL careers

Young Adult Pathways

Opportunity For All (OFA)

- 100 participants since pandemic started
- 80% completed post-secondary
- 60% received permanent employment
- 50% of participants undocumented
- 30% of participants are monolingual spanish speakers

CARE Ambassadors

- 48 young adults graduated from OFA into the ambassador program
- 98% placed in employment and/or post-secondary
