3	Resolution urging the Mayor and the Board of Supervisors to protect lesbian, gay, bisexual,
4	transgender, queer, or questioning (LGBTQQ) youth by supporting a California ban on efforts
5	to change youth's sexual orientation.
6	
7	WHEREAS, Being lesbian, gay, bisexual, transgender, queer, or questioning (LGBTQQ) is not
8	a disease, a disorder, illness, deficiency, or shortcoming; and
9	
10	WHEREAS, The major professional associations of mental health practitioners and
11	researchers in the United States have recognized these facts for nearly 40 years; and
12	
13	WHEREAS, There are a small fraction of mental health professionals that practice conversion
14	therapy, also known as reparative therapy, which is an effort to change one's sexual orientation and/o
15	gender identity from LGBTQQ into a straight and gender conforming person; and
16	
17	WHEREAS, Conversion therapy is not a form of psychiatry or psychology because its origins
18	are from religious ideology, not science; and
19	
20	WHEREAS, Telling LGBTQQ youth at such a vulnerable age that who they are is not
21	acceptable further shames and dehumanizes them when they already receive that message every day
22	through the bullies at school and on the streets; and

1	WHEREAS, Conversion therapy by definition is an attempt to forcefully change people's
2	naturally occurring sexual orientation and gender identity and replace it with a straight orientation; and
3	
4	WHEREAS, In the past 40 years "reparative therapists" have not produced any rigorous
5	scientific research to substantiate their claims of cure; and
6	
7	WHEREAS, "Not only is homosexuality 'not a choice,' as most efforts to try and change a
8	person's sexual orientation fail, but some attempts to change can cause harm and damage to an
9	individual's well-being," as Dr. Jack Drescher, MD, a Distinguished Fellow of the American Psychiatric
10	Association and a member of the DSM-5 Workgroup on Sexual and Gender Identity Disorders, has
11	said; ² and
12	
13	WHEREAS, Conversion therapy is routinely forced on young people without their consent; and
14	
15	WHEREAS, Practitioners of conversion therapy can use various methods including prayer,
16	exorcism, counseling, aversion therapy (i.eshocking people while showing gay images), lobotomies,
17	torture, and rape; and
18	
19	WHEREAS, One gay youth in Iowa was beaten repeatedly by his father, a pastor, after coming
20	out at age 12. He was told by a counselor "he had AIDS, that he was the only gay person in the
21	country and the government would kill him if they found out. His hands [were] burned and frozen with
22	ice while he was shown images of men hugging" and was electrocuted for a month while shown
23	explicit pictures of men. [He] has since been excommunicated by his family and warned by his father

WHEREAS, The American Psychological Association convened a Task Force on Appropriate Therapeutic Responses to Sexual Orientation, which concluded, "Sexual orientation change efforts can pose critical health risks to lesbian, gay, bisexual [transgender, queer, and questioning] people including confusion, depression, guilt, helplessness, hopelessness, shame, social withdrawal, suicidality, substance abuse, stress, disappointment, self-blame, decreased self esteem and authenticity to others, increased self-hatred, hostility and blame toward parents, feelings of anger and betrayal, loss of friends and potential romantic partners, problems in sexual and emotional intimacy, sexual dysfunction, high-risk sexual behaviors, a feeling of being dehumanized and untrue to self, a loss of faith, and a sense of wasted time and resources;" and

WHEREAS, Every major medical and psychiatric association has come out stating that sexual orientation and gender identity cannot be changed, including the American Academy of Pediatrics, American Counseling Association, American Federation of Teachers, American Psychological Association, The Interfaith Alliance, National Association of School Psychologists, National Association of Social Workers, National Association of Secondary School Principals, and the National Education Association;⁵ and

WHEREAS, Many of the biggest supporters of conversion therapy have since come out saying that this therapy is harmful and ineffective; and

2	WHEREAS, The founders and leaders of Exodus International, the largest conversion therapy
3	organization, have issued a formal apology explaining that efforts to change sexual orientation are
4	ineffective (all the leaders have since come out as gay), and dangerous, and have been quoted as
5	saying, "No one was really becoming 'ex-gay.' Who were we fooling? By calling ourselves 'ex-gay' we
6	were lying to ourselves and to others. We were hurting people;"6 and
7	
8	WHEREAS, The father of modern psychiatry, Robert L. Spitzer, whose work has been used to
9	support conversion therapy, recently came out as saying he made a grave mistake in supporting this
10	harmful practice saying "You know, it's the only regret I have;"7 and
11	
12	WHEREAS, California Senate Bill 1172 (Lieu) would protect LGBTQQ youth from this
13	dangerous and ineffective treatment by banning the sexual orientation change efforts on persons
14	under 18; now, therefore, be it
15	
16	RESOLVED, That the San Francisco Youth Commission strongly urges the Mayor and Board
17	of Supervisors to protect LGBTQQ youth by supporting SB1172, banning conversion therapy for youth;
18	and be it
19	
20	FINALLY RESOLVED, That, in the event that SB1172 does not pass statewide, the San
21	Francisco Youth Commission encourages the Board of Supervisors to craft a similar ordinance
