5	WHEREAS, As stated in Charter 4.124 the Youth Commission is charged with
6	identifying the unmet needs and concerns of San Francisco youth and advising the Board of
7	Supervisors and the Mayor on youth-related issues to bridge the gap between youth and
8	government ¹ , and therefore provides a valuable perspective to the city's re-authorization
9	process of the Children's Fund; and
10	WHEREAS, The Youth Commission has engaged in the Stakeholder's Coalition's
11	community meetings, and played the critical role of planning the Youth Town Hall on behalf of
12	the Our Children, Our City Stakeholder Process; ² and
13	WHEREAS, The Children's Fund, a dedicated stream of funding for youth services in
14	San Francisco, was first approved by San Francisco voters in 1991, reinstated by the
15	electorate in 2001, and is up for reauthorization by 2015; and
16	WHEREAS, The Children's Fund has been the primary source of funding for programs
17	and direct services for the more than 56,000 youth in San Francisco who are 18 years and
18	younger; ³ and
19	WHEREAS, Currently the Children's Fund does not include services that benefit
20	disconnected transitional aged youth that are between the ages of 18 and 24; and
21	WHEREAS, Disconnected Transitional Age Youth (TAY) is defined as youth between
22	the ages of 16 and 24 who need additional support and opportunities to make a successful
23	transition to adulthood; and

1	WHEREAS, There are up to 9,000 ⁴ disconnected transitional age youth in San
2	Francisco who are out of school and out of work and in need of coordinated services; and
3	WHEREAS, disconnected transitional age youth may also be experiencing or at risk of:
4	living in poverty or being low-income; being homeless or marginally housed; being
5	unemployed or underemployed without substantial financial support; being academically off-
6	track or dropping out of school; having been in contact with public systems including foster
7	care, the justice system, and/or special education; are disabled or struggling with other health
8	and wellness issues such as substance abuse, trauma, and mental health issues; are victims
9	of violence; are young parents; are undocumented; are recent immigrants and/or English
10	Language Learners; or are Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning
11	(LGBTQQ) youth who have experienced family rejection; and
12	WHEREAS, In San Francisco, there are 1,160 TAY who are on Adult or Juvenile
13	Probation; 800 who are current or former foster care youth; 5,700 who are homeless or
14	marginally housed; 5,000 are with disabilities; 7,700 who are 18-24 and have not obtained a
15	High School Diploma or GED; 1,400 who receive cash welfare; 4,000 who receive food
16	stamp; 6,000 without health insurance; ⁵ and
17	WHEREAS, Young people in the TAY population have aged out of government
18	programs that serve youth who experience the barriers above, as current Children's Fund-
19	funded City programs do not serve youth over 18, and federal programs do not serve youth
20	over 21; and
21	WHEREAS, DCYF's 2011 Community Needs Assessment reported that at community
22	meetings across San Francisco, youth, parents, community members, and service providers

1	identified out-of-school time programs, youth employment programs, mental health programs,
2	violence prevention, and disconnected TAY services as priorities for older youth; ⁶ and
3	WHEREAS, the formal exclusion of TAY from existing youth-serving programs leads to
4	a loss of data integrity and does not allow us to fully assess the demand and efficacy of
5	existing community programs; and
6	WHEREAS, San Francisco is a sanctuary city which values offering protection and
7	support to undocumented youth; and
8	WHEREAS, Young people directly receive the services of the Children's Fund and
9	should be at the forefront of any decision-making process regarding the Fund; now, therefore,
10	be it,
11	RESOLVED, That the San Francisco Youth Commission does hereby urge the Board
12	of Supervisors of the City and County of San Francisco to consider the following policies for
13	the Children's Fund:
14	 Allowing the use of funding for transitional age youth to be served by existing
15	youth-serving community programs
16	 Allowing the use of funds for serving the specific needs of disconnected
17	transitional age youth
18	 Prioritizing the needs of undocumented youth
19	 Including youth seats in any body that is in charge of oversight of the
20	Children's Fund, including the DCYF Citizens Advisory Committee
21	 Allowing the Youth Commission to appoint youth to oversight body youth
22	seats
23	 Increasing the fund to allow for services to be provided to support the unmet
24	needs of all youth, including disconnected transitional age youth population
