1 [Youth Commission support for maintenance of youth representation on the Our Children, Our 2 **Families Council**] 3 4 Supplemental Information 5 6 Youth Commissioners would like to thank members of the Board of Supervisors for their work on the 7 establishment of the Our Children and Families Council. 8 9 Upon reviewing the proposed amendments to ordinance (File No. 150222), we would like to update 10 our position and recommendations first forwarded to the Board following our March 16, 2015 hearing. 11 We have noted a proposed decrease in youth representation on this body, and write to respectfully 12 urge you to preserve the youth seats, as originally conceived in earlier drafts of this ordinance. While 13 we acknowledge the desire to reduce the overall number of seats on the council to make it of a more 14 manageable size, it is vital to retain youth voice on this Council that aims to integrate city-wide goals to 15 serve children, youth, and their families. In order to have meaningful youth representation, it is also 16 important to ensure there are multiple youth seats so that youth serve alongside other youth, and do 17 not act as the sole youth representative on the Council. 18 19 We are in support of suggestions made from members of the OCOF Stakeholder Council Supervisor 20 Yee has conscientiously been convening: A Youth Commissioner would be elected by the Youth 21 Commission to sit on the 102.2 City Members seat, and a Student Advisory Council representative 22 would be elected by the Student Advisory Council to sit on the 102.3 School District Members 23 School District seat. In addition, under 102.4 Public Members, we would like to recommend keeping 24 seat 4 (who would be a youth who attends public school and is a member of a youth organization), and 25 also seat 5 (who could be a representative from TAYSF). The Youth Commission and the respective
