Commissioner Alioto-Pier had an issue with her email and sent her drafts to staff for approval. All Supervisors have received an email except for Supervisor Stefani and Peskin.

Commissioner Chan has a meeting scheduled with D11 leg aide, Monica, to discuss Vote16 efforts, Commissioner Cheung received communication that Supervisor Fewer would like to co-sponsor Vote16 legislation and the Supervisor Mar would like to have the ballot language (which we don't have just yet but staff sent the 2016 version and the 2019 YC resolution), and Commissioner Arana received communication that Supervisor Ronen would also like to co-sponsor Vote16 legislation.

Commissioners confirmed they will send follow up emails to Supervisors they have not heard from yet by Friday, February 14th. They will then do personal drop ins between February 18-21st and bring a copy of the email they originally sent.
