C. Debrief Full YC from October 19th, 2020

Commissioner Hylton- Last meeting did not have the most energetic engagement. Any suggestions on how to improve or did anyone else feel this?



Commissioner Zhang- I agree and I think partly because people turn their cameras off which I understand but it creates a trend among the other commissioners. I think we can have small check in questions with break rooms where people would be more comfortable with their cameras.

Commissioner Quick- I think it is difficult to keep up engagement when only the people leading the meeting are the ones with their cameras on. I understand zoom fatigue is a real concern however, the same people participate during the meeting. I would push back on adding things to meetings because it seems counterproductive due to their length and virtual format.

Commissioner Asfaw- I agree with Calvin's thoughts because I am in high school all day followed by a long full youth commission meeting. I struggle with participation because of the late night meetings.

Commissioner Hylton- I struggle with the same issues but I thought of implementing breaks however, that would add time to the meeting. I am unsure if that would help, does anyone have any thoughts?

Staff Estrada- I do not want to enforce cameras on because I understand being on camera all day and in school. I do not want the meetings to feel like school. Maybe in our committees we can have the conversation of the same people participating and ask them on how they want to engage during a meeting. Maybe in our next meetings we can make space for the commissioners who have not been as active by not calling them out.

Commissioner Santos- I feel certain times there is more engagement with different topics. Also I recognize participation is going to be different in full youth commissions then in committee meetings. Maybe we can reach out to other commissioners on how they participate during their committee meetings that are very active in their committees. The sense is that the space is made but nobody is stepping in.

Commissioner Quick- I agree with Commissioner Santos, I feel sometimes people have grown reliant on certain commissioners to participate which I dont think is productive.

Commissioner Hylton- I agree with Commissioner Quick. In person it is a different environment than online. It's hard to grasp when people are listening or engaged. Maybe we can reach out to the commissioners to come prepared with questions and emphasize how no question is not a bad question.

Staff Truong- Maybe we should share minutes as live notes to people stepping out and engage when they return. I know as staff we pose our questions through the executive. Another thing is do we need a critical analysis for the full youth commissions such as a doc. The returners have been asking questions not so much with the new commissioners. I do not think commissioners or staff have time for informal study groups or interest for preparing for the meetings.



Commissioner Asfaw- I saw the same pattern last year with the executive committee. It is always certain commissioners that participate. I think returners are dominating the conversation because many are on the executive committee. I think a critical analysis workshop would be helpful but not address the problem.

Staff Truong - We are in a learning phase and people might get comfortable later.

Commissioner Quick- I think some comes from people being comfortable however, there is a spiral circle where the people who were talking the most at the end last year are on this year's executive committee. There are commonly asked questions we learned from previous years, maybe having a document and sending to everyone could help.

Commissioner Zhang- I am hesitant because I do not know everyone that well and I do not want to give off the impression I do not know what I am talking about. Also, with the doc I like the idea because it reminds me when people were able to type about resolutions. In addition, it could help with people who don't know what to ask.

Commissioner Santos- Commissioner Zhang you mentioned how you do not know us that well and it makes sense. I wonder if others feel that way.

Commissioner Zhang- I know you all as youth commissioners, not so much an individual's personality which is difficult during zoom.

Commissioner Santos- I understand and it makes sense. I did not recognize how that impacts someone's work.

Commissioner Zhang- I wish there were more opportunities to get to know each other and a lot of time. Maybe we can focus on getting to know each other in the future.

Commissioner Quick- I am tired of talking about attendance at every meeting.

Commissioner Santos- I echo the same feelings, we discuss it during executive. Many people are clueless about the behind the scenes actions and discussions.

Commissioner Hylton- I agree with Commissioner Santos.

Staff Estrada- I have the same feelings on attendance. There are many unpredictable things that happen. We can continue attendance as we have but if it's to the point where we need to resign we can discuss it when the time comes. I think most of your peers would be understanding.

Commissioner Santos- I totally agree. We need to be okay with uncertainty and not rely on the papers.



Staff Estrada- We will know when the time comes if someone reaches too many absences.

Staff Truong- The issue is not about attendance rather compensation. We should consider our larger fight.

Commissioner Hylton- The main way people excuse their attendance is sharing personal information which seems unnecessary and uncomfortable. I do not want people to feel pressure to do that for perfect attendance.

Commissioner Quick- I am fine with the bylaw language as it exists now however, I suggest returning to our old system of no questions asked absence but we have to monitor it. It does give more freedom and last time we saw a drop of attendances.

Staff Truong- If people have to leave you are marked absent regardless if they were present for the meeting.

Commissioner Asfaw- I do not think giving a reason for their absence is not special to the Youth Commission. In the bylaws we ensure you can be as vague with your excuse. You are in control of your absences but as a commission we do not have to excuse it.

Commissioner Quick- I hear what Commissioner Asfaw shared. The part I am most interested in changing the Bylaws is the timing of one's excuse. I do not feel strongly about keeping or removing proving an excuse for one's absence. The timing seems to be a common problem.

Commissioner Hylton- I do not want people to share details about their life if they are not comfortable but I do not want people to feel pressured to do so.

I followed up with the office on why it has not been passed. The ordinance must go through a barraning process with the Police Officers Association. Should we follow up with Superior Haney's office.
