Discussion - Committees talked more about the process for their BPPs. Commissioner Quick shares more about the budget advocacy timeline. The City is facing a \$411 million deficit in FY 2021-2022, and \$242 million deficit in FY 2022-2023, which totals to \$654 million over the next two fiscal years. They are assuming no federal relief (which could change). They are also assuming \$100 million in expenditures for Covid-19 in both FYs, which again could change, especially in year 2 (FY 2022-2023). Comparatively, the deficit is smaller than it was during the last recession, when our budget was half the size.

- Update on OCOF request on Child and Youth Friendly City request
 - The Child & Youth Friendly SF (CYFSF) initiative is led by OCOF in partnership with UNICEF USA. Utilizing a framework that has been successfully implemented in over 40 countries worldwide, we are on a mission to change the culture, policies, and design of our city so that children and youth's needs and voices are elevated in local government decision-making and place-making. Given the Youth Commission's long-standing advocacy for youth voice in legislature and commitment to representing the needs of young people of San Francisco, OCOF would like to ask for the YC's support in a number of areas related to the CYFSF initiative. These areas include the organizing and facilitation of Community Assessments to understand the needs and priorities of San Francisco's children/youth, participation in the CYFSF taskforce workgroups (areas of focus include: Child rights education, COVID response & recovery for youth, and Child friendly policy & budgeting), and establishing a system to track two indicators around youth participation in government.
