5. Presentations (All Items to Follow Discussion and Possible Action)

A. Plastic Straw Ban

Presenters: Kaeli Shaw and Emily Cronan

The presenters cancelled. Staff presented on the legislation BOS File No. 180579, sponsored by Supervisor Tang. The file states: “[this is an] Ordinance amending the Environment Code to prohibit the sale or use in the City of single use food service ware made with fluorinated chemicals and certain items made with plastic; requiring that food service ware accessories be provided only on request or at self-service stations; requiring reusable beverage cups at events on City property; removing waiver provisions; setting operative dates; and affirming the Planning Department’s determination under the California Environmental Quality Act.”



Commissioners have noted the increase in alternative straws made of reusable or compostable materials like paper and metal. Commissioners urge the Board to refer this legislation to the full youth commission. Additionally, Commissioner Lona requests more information regarding the waiver provision language in the amendment. Namely, does the removal of waiver provisions apply to only vendors on City property or does it extend more broadly?

B. Plaza 16 Coalition
Presenter: Youth Commission Staff

Staff presented a report from an initial meeting they had with representatives from the Plaza 16 Coalition. This is a community-based organization representing the geographic area of 16th and Mission and its surrounding neighbors in District 9. The Coalition represents over 100 different organizations; and organizes against gentrification, displacement, and luxury developments; and supports housing rights in the mission. In addition to opposing the 1979 Mission luxury development, “the monster in the mission”, they suggest an alternative development, “the marvel” which was developed by the community.

Commissioners have some questions for the Plaza 16 coalition organizers. Commissioner Lind would like to know what alternative pharmacy outlets are being considered as Walgreens will be demolished. Commissioner Marshall-Fricker would like more information on how they plan to fund 100% affordable housing.
