 A. [Inform + Decision] Protecting and Establishing Cantonese Programs at City College Presenter: Alan Wong, City College of San Francisco Board of Trustee (Document E)



Problem: at City College, Fall 2022 semester we almost cancelled our Cantonese program because currently the class is not UC transferable or leads to a certificate. CCSF gets money for certificate led courses. CCSF has 9 other languages that all have certificates. This is something that is important to the community because it enables young people to learn Cantonese and be bilingual. Personally, there was an older cantonese woman at the hospital that needed help and asked me for help because there was no one else who spoke cantonese. She shared her experience that she was assaulted on the 15 bus and couldn't get help from the police or hospital staff as they did not speak her language. Imagine if you aren't english speaking and the police don't speak the language and are using an app to help, this app doesn't capture the colloquial terms that this woman may have been using.

The cantonese program is not only about learning the language, but also the ability to be of better service to the community.

My resolution is simple: make the classes UC transferable and available to receive a certificate.

My ask: the YC supports this resolution and submit a letter of support. This has already been supported by many other allies and community based organizations.

Questions:

- Commissioner Santos: thank you for bringing this up to our attention. I myself was a CCSF student and understood the bureaucracy of the school. I know how I will be voting.
- Commissioner Zhang: will this go into effect right away?
  - Answer: our articulation officer will work with the UC system to make it transferable, look into the curriculum and make any adjustments that may be needed. To create a certificate we need the buy-in from faculty and staff. This will go through those checks and balances. The faculty will need to create a program and will need to be approved by the faculty senate, and then the board of trustees for approval.
- Commissioner Zhang: could you describe how the YC or YCers support this matter?
  - Answer: I can share the other letters that other organizations have written. Please send it over to me.
- Commissioner Santos: the anecdote I heard about the language barrier was this to highlight the community importance?
  - Answer: yes, it's about the community connection and to establish the real life need for this. If we don't have people who speak cantonese then it's almost as if they don't exist.
- Commissioner Zhang: How many people are interested in the program?
  - Answer: we have 2-3 classes available, since 2019 they have always been at capacity.







# What We've Heard

The majority of people we spoke with described how JFK Drive has become a new destination within the park for them and that the promenade has been a joyful and valuable addition to their park experience. **We have also heard:** 

- Some people with disabilities and older adults feel that the amount of blue zone parking is inadequate and too far from their intended destinations with the removal of parking on JFK Drive.
- Neighbors feel like the removal of JFK Drive from the street network has added to traffic congestion.
- Some people who disagree with the overall closure of JFK Drive to vehicular traffic also believed that the public process is rushed and not sufficient.



## What We've Heard

- Few people knew that a shuttle in the Park is available to people with disabilities and others; those who were aware described the shuttle as underperforming and not useful.
- Many people who drive to the park find the parking situation challenging and confusing.
- Some people would like park-enhancing experiences and interpretive elements as part of mobility solutions within the park.
- On car-free streets, some users felt that cyclists and other faster users on the promenade make other slower moving users feel uncomfortable and less safe.
- Transit service to the Park isn't viable for everyone and current service is slow.
- We need to do more to make Golden Gate Park feel more welcome to Black and Brown communities.

1	[Safe Storage for Firearms Resolution]
2	
3	Resolution urging the San Francisco Unified School District and all San
4	Francisco schools to share safe firearm storage information with families
5	annually.
6	WHEREAS, Gun violence is a national crisis and disproportionately affects youth and
7	young adults; and,
8	
9	WHEREAS, Gun violence is the leading cause of death for children and teens in the
10	United States, recently overtaking traffic incidents (per the Children's Defense Fund); and,
11	
12	WHEREAS, On average, every year in the United States, nearly 350 children ages 17
13	and under gain access to a firearm and unintentionally shoot themselves or someone else,
14	and, on average, every year nearly 700 children, 17 and under, die by suicide with a firearm
15	(per <u>Everytown Research</u> ); and,
16	
17	WHEREAS, San Francisco is not immune to the national gun violence epidemic, as our
18	communities have seen a dramatic increase in gun violence within the past year; and,
19	
20	WHEREAS, Black Americans are disproportionately impacted by gun violence,
21	experiencing 10 times the gun homicides, 18 times the gun assault injuries, and nearly 3
22	times the fatal police shootings of white Americans; and,
23	
24	WHEREAS, BIPOC (Black, Indigenous, and People of Color) children and teens are 4
25	times more likely to die from gun violence than their white peers; and,

1	WHEREAS, The high school shooting in Oxford, Michigan on November 30, 2021, in
2	which the alleged shooter was able to access the firearm used because it was not securely
3	stored, highlights the importance of safe storage of weapons for families; and,

5	WHEREAS, Most school shootings are committed using a firearm a student accessed
6	at home or at the home of a close relative; and,
7	
8	WHEREAS, Firearm purchases, and therefore homes with firearms, have increased
9	since the the beginning of the COVID-19 pandemic in the United States; and,

11	WHEREAS, Evidence strongly suggests that secure firearm storage is an essential
12	component to any effective strategy to keep schools and students safe; and,
13	
14	WHEREAS, Research shows that secure firearm storage practices are associated with
15	up to an 85 percent reduction in the risk of unintentional firearm injuries among children and
16	teens; and,
17	WHEREAS, Keeping students, educators, and staff safe is the responsibility of all adult
18	stakeholders at every school site; and,
19	WHEREAS, San Francisco law (San Francisco Police Code § 4512) and California law
20	(California Penal Code § 25100) requires that firearms are securely stored so that minors
21	cannot gain access to them; and,
22	WHEREAS, The California State Superintendent has urged school districts to send
23	secure gun storage information to parents and families; and,
24	WHEREAS, the " <u>Be SMART</u> " campaign ( <u>S</u> ecure, <u>M</u> odel, <u>A</u> sk, <u>R</u> ecognize, <u>T</u> ell) is a
25	nationwide campaign from Everytown for Gun Safety promoting safe firearm storage, which

emphasizes that it's an adult responsibility to stop kids from accessing guns, and that every
adult can play a role in keeping youth and communities safer; and; now, therefore, be it

RESOLVED, That the San Francisco Youth Commission calls on all San Francisco
schools, including the San Francisco Unified School District (SFUSD), parochial schools,
charter schools, private schools, and other independent schools, to share information to
families that explains the importance of secure gun storage and the legal obligations to protect
minors from accessing irresponsibly stored guns; and, be it

FURTHER RESOLVED, That SFUSD and parochial schools, charter schools, private
schools, and other independent schools use the "Be SMART" campaign from Everytown for
Gun Safety as a foundation to begin the implementation and include it in the annual
registration materials at each school site, and requiring a signature acknowledging awareness
of secure gun storage responsibilities; and,

FURTHER RESOLVED, That the San Francisco Youth Commission calls on all San
Francisco schools, including SFUSD, parochial schools, and other independent schools, to
update their Student Handbooks to include information about parents' legal obligations
regarding the secure storage of firearms (the "Be SMART" campaign from Everytown for Gun
Safety can be used for reference/resources).

Dear Board of Supervisors & Mayor London Breed,

The Youth Commission (YC) urges you to take action on student safety during the pervasive rise of the Omicron variant in our San Francisco schools. Students, especially those from public schools have felt unsafe due to the lack of communication and lack of compromise in learning systems for students. Students deserve to be part of the decisions that are impacting their lives. The survey conducted by the San Francisco Unified School District's (SFUSD) Student Advisory Council (SAC) revealed 57.9% of students felt unsafe or somewhat unsafe attending school in-person, which constitutes over half the student survey pool, while only 14.7% of students to be present in person, it is crucial that SFUSD, charter, & private schools create safe structures, provide adequate personal protective equipment (PPE), and testing kits to teachers, students, and school staff. We urge you to consult with students, teachers, and unions to pass policies that keep everyone's safety a top priority.

The Youth Commission is a body of 17 youth from San Francisco between the ages of 12 and 23. Created by the voters under a 1995 amendment to the City Charter, the commission is responsible for advising the Board of Supervisors and the Mayor on policies and laws related to young people. The YC is also charged with providing comment and recommendation on all proposed laws that would primarily affect youth before the Board takes final action. Additionally, the YC set forth in Motion 2021-AL-09 to interpret Section 4.124 of the City Charter as requiring the Board of Supervisors to refer legislation related to the City's relationship with SFUSD to this body for comment and recommendation, provided that such legislation also meets all existing criteria for Youth Commission referral, as defined by the City Charter.

The YC supports the demands of the SAC as <u>stated in a letter</u> sent to Superintendent Matthews, Commissioners of the Board of Education, and SFUSD administrators on January

9th, 2022. We stand with the findings of the Student Advisory Council in providing a hybrid option so that students are able to stay healthy and safe without sacrificing their education. If hybrid learning is unavailable, we also stand with SFUSD excusing the absences of students who choose to stay at home. We also agree that there should be more communication and transparency to SFUSD students regarding testing options, recommendations, and resources for safety.

As we enter a world where the short-term impacts of the COVID-19 pandemic become increasingly clearer while the long term effects remain unclear, it's important that we take measures now to ensure the wellbeing of all young people, especially the City's most vulnerable youth.

Thank you for your attention to this urgent matter.
