L. Motion to Support 6 Million Dollars for a Designated TAY Navigation Center and Urge the City to Fund Homeless Youth Services Proportional to the Homeless Population

The Mayor has introduced 6 million towards a new Navigation Center and, previously, the Board of Supervisors had voted that at least one of the new centers should go towards the TAY population. Supervisor Sheehy is wanting to make sure that this new one will be designated for TAY and wants the YC to go on record of supporting this since we wrote about this exact issue in our BPP document. Two ways to go about this: take it to a full YC meeting and pass a general motion of support or if no meeting on the 19th have EC draft up a memo saying YC supports this as per our BPP issue. Commissioners would like to do some research on where this center could be held as related to amount of queer youth in the homeless population and suggesting Castro be an option.

M. Discussion on Upcoming Budget Hearings and Mobilizations

Today is budget mobilizations, Thursday and Friday are Budget and Finance Committee meetings with different departments and agencies. However, only public comment will be held on Monday starting at 10am, but caveat is that there is no way to tell what time it will open up or conclude.
