

1 [Supporting the Funding Ask of HYPE (Helping Young People Elevate) Center]

2 **Motion to support the HYPE Center's endeavors in providing key resources to**
3 **marginalized and trafficked youth.**

4 WHEREAS, The San Francisco Department for Children Youth and Families
5 (DCYF) has made recent funding decisions that result in no funding for youth sex
6 trafficking prevention or support in our city, significantly impacting vulnerable
7 populations; and

8 WHEREAS, Freedom Forward, a San Francisco nonprofit organization, is
9 dedicated to serving young people who are vulnerable to sex trafficking, particularly
10 focusing on youth ages 14-24, who are increasingly being trafficked and experiencing
11 homelessness due to systemic and economic barriers; and

12 WHEREAS, disproportionately affected youth are more vulnerable to sex
13 trafficking due to financial barriers; and

14 WHEREAS, Freedom Forward's HYPE Center (Helping Young People Elevate)
15 is San Francisco's only multi-service drop-in center that specifically aims to prevent
16 commercial sexual exploitation of youth, offering a wide array of services such as
17 mental health support, legal assistance, housing access, and basic needs like food and
18 showers, through a coordinated effort with over 20 youth-serving partners (LYRIC,
19 Westcoast Children's Clinic, YLI, etc.); and

20 WHEREAS, The HYPE Center has successfully served over 500 unduplicated
21 youth members, predominantly from BIPOC, LGBTQ+, and homeless communities,
22 providing them with essential support and preventing repeated exploitation; and

1 WHEREAS, individual success stories illustrate the profound impact the HYPE
2 Center has on young people’s lives, offering them a safe space, necessary resources,
3 and a supportive community that enables them to escape cycles of exploitation and
4 homelessness; and

5 WHEREAS, The initial funding for the HYPE Center through the California
6 Department of Social Services (CDSS) under the SF SOL initiative is coming to an end,
7 requiring new independent funding to continue its critical services; and

8 WHEREAS, The HYPE Center requires an annual investment of \$875,000 for
9 2025 and 2026 to sustain its programming, continue serving the vulnerable youth
10 population, and secure a permanent funding stream; and

11 WHEREAS, The potential closure of the HYPE Center due to lack of funding
12 would leave 534 youth members without a dedicated space for addressing their basic
13 needs and accessing specialized services, thus exacerbating their vulnerability to
14 sexual exploitation; and

15 WHEREAS, Mayor London Breed has publicly supported efforts to prevent youth
16 exploitation and chronic homelessness, recognizing the importance of such initiatives
17 for the city’s most vulnerable residents; and therefore be it

18 MOVED, That we urge the City of San Francisco to allocate an annual \$875,000
19 investment for the HYPE Center for the years 2025 and 2026 via add-back dollars; and

20 MOVED, That this funding will ensure the continued operation of the HYPE
21 Center, enabling it to serve the vulnerable youth community and prevent the closure of
22 this vital resource; and

1 MOVED, San Francisco Youth Commission recognizes the essential role of the
2 HYPE Center in preventing youth sex trafficking and exploitation, and commits to
3 embedding HYPE into the fabric of services within the nonprofit sector to support and
4 protect our youth.
