1. Call to Order and Roll Call

The meeting was called to order at 5:04 pm.

Commissioners present: Amable, Mesler, Matz, Juarez. Commissioners absent: Krause (was ill), Galeano (had school conflict), Blacksher (had a family concern). Staff present: Adele Failes-Carpenter.

2. Approval of Agenda (Action Item)

Commissioner Matz, seconded by Commissioner Juarez, moved to approve the agenda. There was no public comment. The motion was approved by acclamation.

3. Approval of Minutes (Action Item)

A. October 25, 2016 (Document A)

Commissioner Matz, seconded by Commissioner Mesler, moved to approve the minutes. There was no public comment. The motion was approved by acclamation.
