1. Call to Order and Roll Call

The meeting was called to order at 5:06 pm. All members were present. Staff present: Adele Failes-Carpenter.

2. Approval of Agenda (Action Item)

Commissioner Matz, seconded by Commissioner Juarez, moved to approve the agenda. There was no public comment. The motion was approved by acclamation.

3. Approval of Minutes (Action Item)

A. November 1, 2016 (Document A)

Commissioner Krause, seconded by Commissioner Mesler, moved to approve the minutes. There was no public comment. The motion was approved by acclamation.

4. Public Comment on Items not on Agenda (Discussion Only)

There was no public comment.

5. Business (All Items to Follow Discussion and Possible Action)

A. Reviewing committee "group agreements"

There was no public comment.

B. Debrief November 15th joint hearing between BOS and Police Commission and review upcoming hearing dates

Committee members debriefed their public comment turnout event for the hearing:



Pluse's: Good turnout from youth and community organizations; Great public comment from youth; Supervisor Tang and SFPD Captain following up to thank YC'ers for coming; YC were respectful, but didn't mince words; Using 'I' statements; Developing relationship with police commissioners

Delta's: Item was late and public couldn't stay; Sheriff were in riot gear and doing additional bag searches, which discouraged some youth; Personally, YC'er wished they had divided info coordinated their comments to avoid repetition and written them down verbatim; Not being acknowledged for being in the room; Needed to have a press contact or press preparation; Presentation from SFPD didn't clearly address the plan for responding to the findings in the DOJ and Blue Ribbon investigations.

Insights: Next time, have the youth who have to leave record a video that someone can play during public comment; YC staff are thinking about how to prepare youth coming to city hall to be ready to interact with law enforcement/be searched/what to expect;

There was no public comment.

C. Review SFPD priorities

YC motion regarding YC priorities for hiring of a new police passed. Those recommendations were:

- a. Training officers on adolescent development and effectively interacting with youth
- b. Full implementation of MOU and MOU oversight
- c. Ongoing training on protocols for arresting parents
- d. Ongoing communication between new chief and youth advocates, ie, chief's youth roundtable or youth role at police commission meetings

Staff had an initial phone conversation with Capt. Yee (Leads Academy that trains new recruits), Lt. Dangerfield (Youth & Community Engagement Unit); Capt. Overseeing district stations reached out to Youth Commissioners after BOS hearing and is willing to be in touch. Update from those conversations:

- e. New recruits/officers are receiving training on protocols for arresting parents.
- f. There is a new Lt. assigned to School Resource officer program
- g. Recruits are not receiving training on the SFUSD-SFPD MOU
- h. Capt. Yee shared an outline of the juvenile policing training used in the academy, mostly focused on welfare and institutions code
- i. Capt. Yee and Lt. Dangerfield would like to invite YC to visit academy and meet with him <u>and</u> visit SFPD HQ to meet with youth & community engagement unit.

Staff are talking with Office of Citizen Complaints (being renamed Dept. of Police Accountability) this week

D. Work time in committee breakouts: Employment, Justice, Immigration

 - What is going to be done with City funds that were earmarked for legal aid or DACA application fees? How else can they be used?
 - What can the City do to fulfill the financial aid needs of students that may lose federal aid in January? For instance, with the passage of Prop W and the establishment of the Free City College Fund, could there be a scholarship fund for undocumented students transferring to CSU?
 - What can the city do to continue to offer workforce development opportunities for young workers on DACA, if DACA is revoked?
