A. Presentation on Youth Leadership Institute's Health Impact Project - Policy Advocacy Program

Presenter: Youth Commission Staff

(Document B)

The Youth Leadership Institute is applying for a grant where they would like to implement a Youth Advising Body for the Department of Public Health. DPH is willing to sign on with the caveat that they would like date/info on existing youth advising/decision making bodies and the impact they have in SF. YLI knows that the YC is a powerful and dynamic youth serving body in SF. Assessment would look (and up to youth involved in project) like surveys, interviews, focus groups. Assessment to understand structures in place and potential impacts and the way young people feel to best inform the value of it.

Direct ask: YLI, with youth as researchers, would do a campaign, and the middle piece would be partnership with the YC to do their methodology and implement it. 1-2 hours with the Youth Commission is requested to collect data and then analyze it.

Commissioner Tam, seconded by Commissioner Franet, motion to support the Health Impact Project and to open up the YC to assessment when the time comes. Motion passed by acclamation.

B. Presentation on BLING Grants
Presenter: Natan Sebhatleab, Program Coordinator, Youth Leadership Institute

Highlighting outstanding partnership between YLI and the Youth Commission: have passed health policy on decreasing smoking, YC funded for voter pre registration project, and supported YC in Vote16 work. YLI has supported Youth Commission's all over the Bay Area.

YLI would like the YC's help in getting out the support of BLING program. Focus is building and deepening partnerships and centering youth voices in the city.

Past funded projects: media campaigns, youth scholarships, immigration rights projects, murals, youth policy efforts, etc. Possible ways for you all to help us lead in outreach efforts:

- 2) reach out to folks you know and pass on Natan's info

Natan is committed to youth being more involved in having a voice and centering it.



#### Questions:

Commissioner Tam-what is age range? 13-18

Commissioner Amable-has to be written by youth? Yes. Need adult allies to help get things in order but want it as youth led as possible.

Commissioner Amable-anything you want to see in new proposals? Want an emphasis on social justice and policy change.

Commissioner Tam-have you reached out to the schools? Yes, mostly coordinate with wellness coordinators and principals. Hard to get info to schools with teachers getting bombarded with things. Tam-can give student gov't coordinator Natan's info.

Commissioner Andam-looking for more school specific projects? Not necessarily, it's just easier to go through schools. Ask that projects are based out of a school and/or non profit.

Commissioner Vigil-would you be willing to work with charter schools? Yes, not exclusive to any youth group. All youth are welcome to apply.

Commissioner Franet-dates? Early bird is this Friday October 27<sup>th</sup> and the actual deadline is November 10<sup>th</sup>.

Commissioner Gregory-if we submit after 27<sup>th</sup> could it still go to early bird? We would try but give priority who turned in on time.

Commissioner Andam-how is BLING planning to work with other community philanthropists? Has strong relationship with YEF and has observed them and their process and expertise. Try to collaborate with others on what projects their funding so the same group isn't getting all the money from each philanthropy source.

Commissioner Amable would like to be a cosponsor and wants to see line 17/18: add the countries after the cities, line 20/21 says South Korean women and wants it to include other ethnicities that were impacted.

Commissioner Andam-did Commissioner Mao want to do this resolution because of the conflict with Osaka? Yes

Commissioner Andam-what are repercussions of SF keeping the statue? Can have sponsors look into that.

Commissioner Franet-doesn't really matter if there are repercussions we should move forward regardless.

E. Motion in favor of writing a thank you to Jerry Brown for his support of Youth Justice Reform

Sponsor: Justice and Employment Committee

Info: 3 bills that had to do with justice reform that were on governor's desk when JECs discussed it and started work on a resolution but then Governor signed all into law. Resolution now turned into just doing a thank you.

One eliminated sentence of life without parole for those under 18.

One would extend youth parole to the age of 25 vs 23.



Last one was Miranda reform to get anyone under 16 to talk to counsel before they waived Miranda rights. Police lie to get their job done and those under 16 it is easy to get them to admit to crimes they didn't commit so good to have youth talk to counsel first.

Commissioner Tam, seconded by Commissioner Nassiri, motioned to to send thank you letter.

Motion was approved by acclamation.

F. Protocol on Connecting with City Staff and Elected Officials Presenters: Youth Commission Staff

Staff explained why it was important to consult with staff BEFORE reaching out to department heads, Sup offices, or office of the Mayor. We don't want to be gate keepers, but we are trying to keep track of 17 different people who are rearing to go. # **LEGISLATIVE DIGEST**

[Administrative Code - Indigenous Peoples Day]

Ordinance amending the Administrative Code to declare the second Monday in October to be Indigenous Peoples Day.

# **Existing Law**

The City currently refers to the second Monday in October as Columbus Day

# Amendments to Current Law

The proposed ordinance would amend the Administrative Code to recognize the second Monday in October as Indigenous Peoples Day rather than Columbus Day. The ordinance would require all official City communications to refer to that day as Indigenous Peoples Day. The proposed ordinance does not affect the recognition or non-recognition of the second Monday in October as a holiday for City departments and employees.

10	Be it ordained by the People of the City and County of San Francisco:

12	Section 1. Section 16.4 of the Administrative Code, entitled "Hours of City Offices," is
13	hereby renumbered as Section 16.3 of the Administrative Code. No changes are made to the
14	wording or substance of that Section.
15	
16	Section 2. The Administrative Code is hereby amended by adding new Section 16.4,
17	to read as follows:
18	SEC. 16.4. INDIGENOUS PEOPLES DAY.
19	(a) Findings.
20	(1) San Francisco has a responsibility to oppose the systematic racism towards
21	indigenous peoples in the United States, which perpetuates high rates of poverty and income inequality
22	exacerbating health, education, and social crises among Native Americans.
23	(2) San Francisco recognizes the historic discrimination and violence inflicted upon
24	indigenous peoples in the United States, including their forced removal from ancestral lands, and the
25	deliberate and systematic destruction of their communities and culture.

1	(3) In the late 1970's, a movement began to replace the Columbus Day holiday with a
2	celebration known as Indigenous Peoples Day to recognize and commemorate the contribution of
3	indigenous peoples to the United States and to condemn the atrocities that were committed against
4	them. Many cities and states have since chosen to recognize Indigenous Peoples Day on the same date
5	as, and in lieu of, Columbus Day.
6	(4) In 2011, the Affiliated Tribes of Northwest Indians, representing 59 Tribes from
7	Washington, Oregon, Idaho, Northern California, Western Montana, and Alaska, passed Resolution
8	#11-57 expressing "Support to Change Columbus Day (2nd Monday of October) to Indigenous
9	Peoples' Day."
10	(b) The second Monday in October each year shall be known as Indigenous Peoples Day. All
11	official City communications, notices, calendars, and other publications, whether electronic or paper,
12	of the City shall refer to that day as Indigenous Peoples Day rather than Columbus Day.
13	(c) Within 30 days of the effective date of the ordinance enacting this Section 16.4, the City
14	Administrator shall notify all City boards, commissions, committees, and other bodies, and all City
15	departments, of the requirements of this Section.
16	(d) This Section 16.4 does not affect the recognition or non-recognition of the second Monday
17	in October as a holiday for City departments and employees.

1	Section 3. Effective Date. This ordinance shall become effective 30 days after
2	enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
3	ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
4	of Supervisors overrides the Mayor's veto of the ordinance.

# RESOLUTION NO.

1	[Urging the Federal Government to Extend Temporary Protected Status (TPS) for All Nations Currently Under the Program]
2	
3	Resolution urging the Federal Government to extend Temporary Protected Status (TPS)
4	for all thirteen nations currently included in the program, and to establish a pathway to
5	permanency for these recipients.
6	
7	WHEREAS, Temporary Protected Status, or TPS, is a temporary, renewable program
8	that provides relief from deportation and access to a work permit for certain migrants from a
9	small number of countries who may not meet the legal definition of refugee but who cannot
10	safely return to their country of origin; and
11	WHEREAS, Under current law, the Secretary of Homeland Security may designate a
12	country for TPS when one of three circumstances occurs: There is "ongoing armed conflict"
13	that creates unsafe conditions for returning nationals; there has been an earthquake, flood,
14	drought, epidemic, or other natural disaster that makes the state temporarily unable to accept
15	the return of its nationals, and the state has requested TPS designation; or "extraordinary and
16	temporary" conditions in a state prevent its nationals from returning safely; and
17	WHEREAS, The TPS provision in the Immigration and Nationality Act states that a bill
18	or amendment that provides for the adjustment to lawful temporary or legal permanent
19	resident (LPR) status for any migrant receiving TPS requires a supermajority vote in the
20	Senate (i.e., three-fifths of all Senators) voting affirmatively; and
21	WHEREAS, Provisions that would have allowed nationals from various countries that
22	have had TPS to adjust to LPR status had been introduced in past Congresses, but not
23	enacted; and
24	WHEREAS, On January 25, 2017, President Trump signed Executive Order 13768,
25	Enhancing Public Safety in the Interior of the United States, which was later implemented

1	through a memorandum signed by the Secretary of Homeland Security on February 20, 2017;
2	and
3	WHEREAS, These executive actions dramatically increased the universe of immigrants
4	subject to deportation, eliminating the Obama Administration's enforcement priorities; and
5	WHEREAS, Consequently, many beneficiaries will not only become subject to
6	deportation, but will be at serious risk because DHS has extensive and updated records on
7	their places of residence and work; and
8	WHEREAS, The highest number of these TPS holders come from El Salvador, Haiti,
9	and Honduras; and
10	WHEREAS, California is home to the largest population of TPS beneficiaries in the
11	country, with 55,000 people in the state, including an estimated 15,000-20,000 of those
12	individuals living in the San Francisco Bay Area; and
13	WHEREAS, Many TPS beneficiaries and their families have deep ties to San
14	Francisco, the Bay Area and other communities across the nation, where they have started
15	businesses, built community, bought homes and positively contributed to the social, cultural
16	and economic fabric of cities and this nation; and
17	WHEREAS, An end to TPS would harm not only 350,000 beneficiaries nationwide, but
18	also a far greater number of family members; and
19	WHEREAS, An end to TPS would harm the San Francisco Bay Area, State, and
20	National economy with a projected \$45 billion reduction to the national GDP over a decade,
21	\$6.9 billion in lost Social Security and Medicare contributions over a decade, \$1 billion in
22	turnover costs to businesses, and \$3.1 billion in costs to the federal government to deport all
23	TPS holders from El Salvador, Haiti and Honduras; and

1	WHEREAS, Conditions in designated TPS countries remain dangerous and unsafe,
2	such that deportation to these nations not only separate families, but place individuals and
3	their families at grave risk; and
4	WHEREAS, An end to TPS would harm San Francisco and the Bay Area by throwing
5	the lives of long-term city residents into chaos, separating parents from their children,
6	impacting local small businesses and ultimately damaging the social and economic fabric of
7	our city, and undermining our local values of inclusion and protection for All; now, therefore,
8	be it
9	RESOLVED, That the San Francisco Board of Supervisors urges the Federal
10	Government to extend TPS by no less than eighteen months (18 months) for all designated
11	countries; and be it
12	FURTHER RESOLVED, That the San Francisco Board of Supervisors urges the
13	Executive Branch and Legislative Branch of the Federal Government work together to
14	legislate a pathway to permanent residency for TPS beneficiaries, some of whom have been
15	protected under the program for close to two decades.

1	[Resolution to Support the Erection of the Comfort Women Statue in St. Mary's Square]
2	Resolution supporting the memorialization of comfort women and other atrocities
3	committed by the Japanese Imperial Army during the 2nd World War.
4	WHEREAS, the Japanese Imperial Army committed countless atrocities across the Asian
5	continent ranging from human experimentation by Unit 731 and Unit 100 of the Japanese military to
6	massacres in Manila, Philippines and Nanjing, China to name a few[9,10,11,12]; and
7	WHEREAS, there were as many as 200,000 women and girls taken from occupied countries
8	such as Korea, China, the Philippines, which constituted a majority of the comfort women population,
9	and smaller groups originated from other Asian countries, and even places like Australia and the
10	Netherlands, where they were used in brothels during World War II by the Japanese military <sup>[1]</sup> ; and
11	WHEREAS, Tokyo refuses to admit atrocities committed in formerly-occupied countries and the
12	events are not taught in their schools <sup>[8]</sup> ; and
13	WHEREAS, the statue was created by Californian Steven Whyte <sup>[1]</sup> ; and
14	WHEREAS, the statue depicts three young girls and a grandmother figure <sup>[1]</sup> ; and
15	WHEREAS, it was first unveiled in St. Mary's Square on September 22nd, 2017 <sup>[1]</sup> ; and
16	WHEREAS, many comfort women survivors have passed away and only 35 South Korean
17 18	victims are alive today, and many are running out of time for the reparations and apologies they so
19	long seek <sup>[4,5]</sup> ; and
20	WHEREAS, although in 1993 an apology was issued by Japan and a fund was created for the
21	victims, the fund relied on private donors and was never fully accepted by the South Korean
22	government <sup>[1,3]</sup> ; and
23	WHEREAS, in 2015 South Korea and Japan came to an agreement that Japan would make an
24	apology, and a promise of \$8.3 million dollars to a foundation used to care for the victim, and South
25	Korea agreed to never criticize Japan over the issue again <sup>[1,3]</sup> ; and

1	WHEREAS, the agreement has been criticized by activist groups as they were not consulted
2	enough, and many Koreans want the decision reversed <sup>[1,5]</sup> ; and
3	WHEREAS, survivors are still haunted by their experiences: "It was my first time and that
4	experience really caused me so much pain I cooked for and prepared the needs of Captain Sakuma
5	in the morning, while at night he would lie beside me and forced me to make love with him. I did not
6	put up any resistance every time he would have sex with me, because I was afraid of being hurt. After
7	he was through, I would go to the [lavatory] and douche myself." -Ma Fe Yabut Santillan, the
8	Philippines <sup>[6]</sup> ; and
9	WHEREAS, the survivors are not only psychologically tormented by their experiences, but
10	some were physically harmed like having their uteruses removed[7]; and
11	WHEREAS, San Francisco's sister city Osaka, Japan has threatened to sever ties with San
12	Francisco over the statue, calling the issue "Japan-bashing" and "a one-sided view" [1,2]; and
13	WHEREAS, 40 statues dedicated to the same message of memorializing Japan's wartime sex
14	slaves have been erected in South Korea, and 10 in the United States including Virginia, New Jersey,
15	and Southern California <sup>[1]</sup> ; and now therefore be it
16	RESOLVED, that the threats by San Francisco's sister city Osaka will not deter the San
17 18	Francisco Youth Commission from standing on the side of truth; and be it further
19	RESOLVED, that the San Francisco Youth Commission encourages the Board of Supervisors
20	and Mayor Ed Lee to encourage the Japanese government to recognize all atrocities committed by the
21	Japanese Imperial Army during WWII; and be it further
22	RESOLVED, that the San Francisco Youth Commission stands by the freedom to express
23	oneself including through the use of art; and be it finally
24

1	RESOLVED, that the San Francisco Youth Commission encourages the Board of Supervisors
2	and Mayor Ed Lee to encourage the Mayor of Osaka to rethink his threats to sever ties with San
3	Francisco and to resolve this through open dialogue between our sister cities.
