**1. Call to Order and Roll Call**

The meeting was called to order at 5:16 pm. Commissioners present: Galeano, Amable, Blacksher, Krause, Mesler, Matz. Commissioner Juarez noted present at 5:38 pm. Staff present: Adele Failes-Carpenter. There was quorum.

**2. Approval of Agenda (Action Item)**

Commissioner Matz, seconded by Commissioner Galeano, moved to approve the agenda. There was no public comment. The motion was approved by acclamation.

**3. Approval of Minutes (Action Item)**

Commissioner Mesler, seconded by Commissioner Matz, moved to approve the minutes. There was no public comment. The motion was approved by acclamation.

**4. Public Comment on Items not on Agenda (Discussion Only)**

There was none.

**5. Business (All Items to Follow Discussion and Possible Action)**

- A. Re-election of Committee Vice Chair

Commissioner Galeano gave notice that she would like to step down from the vice chair role. She nominated Commissioner Blacksher for vice chair, seconded by Commissioner Matz. Commissioner Blacksher declined the nomination. Commissioner Galeano nominated Commissioner Krause for vice chair. Commissioner Matz seconded. Commissioner Krause accept-



ed the nomination. There was no public comment. Commissioner Krause was elected vice chair unanimously by acclamation.

B. Election of committee 2016-17 representative to Juvenile Justice Coordinating Council

Commissioner Galeano and staff gave an overview of the JJCC charge and meeting times. Commissioner Blacksher nominated herself for the role, seconded by Commissioner Matz. Commissioner Mesler nominated himself for the role, seconded by Commissioner Galeano. There was no public comment. Commissioner Blacksher was elected unanimously by roll call vote.

C. Review past youth-police priorities and updates regarding search for new police chief

Youth commissioners read priorities 5 and 9 from the 2015-16 YC Budget and Policy Priorities. Commissioners Galeano, Blacksher, and Mesler indicated they would attend the police commission the following evening to distribute the priorities and urge the police commission to consider them during their hiring process for the new chief. There was no public comment.

D. Informational Review of public safety related issues on 2016 ballot and consideration of committee role in 2016 Young and Future Voters Forum

Commissioners reviewed the voter guide text for propositions Q, R, and G. Commissioners Blacksher, Galeano, Krause, and Amable were all interested in co-facilitating roles at the October 20<sup>th</sup> Young & Future Voters' Forum. There was no public comment.
