A. Presentation on Youth Town Hall on Civic Engagement Presenter: Kevine Boggess, Director of Policy and C.J. Amparan, Civic Engagement Coordinator, Coleman Advocates for Youth

CJ, Director of Civic Engagement at Coleman Advocates for Youth, presented on the National Week of Action Against School Pushout, where there will be a Youth Town Hall Event taking place on Wednesday, October 25<sup>th</sup> at June Jordan School from 5:30-7:30pm. Commissioner Lona-you're asking for co-sponsorship of the Town Hall so when you ask for us to help facilitate do you want all of us or select few? And do you want the YC as a whole to cosponsor this? Yes, for the YC as a whole to co sponsor and not all need to be involved. The more the merrier and the more you're involved the greater impact it will have on the community.

Commissioner Lona-asking about the hearings in the resolution and what they mean. YC would be asking BOS to hear what the impacts are and it's able for us to go on record and demonstrate these voices to city government.

Commissioner Marshall- Fricker thinks Fewer might already be holding a hearing.

Commissioner Nassiri-do you have a statement from the White House that says they are targeting communities of color? There is a lot of white supremacy emanating from the White House and the White House wouldn't actually say that, this is a symbolic statement. Commissioner Nassiri-most adults don't take us seriously and we should site where possible where we think the white house does target communities of color.

Commissioner Lona-is it possible to do a quick line amendment and then pass it like that? Yes

Commissioner Mao-can I add myself as co sponsor. Yes.

Staff-you will need accurate footnote citations, and clarity on which acronym for queer community to use.

Commissioner Lona, seconded by Commissioner Vigil, motioned to amend line 4 page 3 to say "disproportionately impact communities of color. Motion was approved by acclamation.

Commissioner Andam, seconded by Commissioner Nassiri, motioned to amend page 3 number 1 to say 'whereas the majority of people are eligible'. Motion was approved by acclamation.

My name is Chiara Lind. As the Chair for the San Francisco Youth Commission (SFYC), I am writing this letter of commitment for the Youth Leadership Institute (YLI) proposal to the Health Impact Project - Policy Advocacy Program. SFYC has partnered with YLI over the past 5 years addressing health equity issues across San Francisco. Recently, Youth Commissioners partnered with YLI to adopt a formal policy re alcohol density in low income communities in San Francisco.

Youth Leadership Institute builds communities where young people and their adult allies come together to create positive community change that promotes social justice and racial equity. For over 26 years YLI has sparked the leadership of young people to solve pressing social issues and serve our communities. We value their commitment to empower transitional age youth leaders throughout the county. YLI is positioned to provide strong leadership and advocacy opportunities, relevant skill building outcomes and system/institutional partnership opportunities with transitional age youth leaders.

The San Francisco Youth Commission supports the vision for this proposed initiative is to institutionalize youth voice in community research and decision-making. They have a proven model in addressing health inequities and through their youth-led action research project to assess youth in decision-making bodies. This project will build provide valuable data and recommendation in exploring the creation of a Department of Public Health Youth Advisory Council.

- Provide opportunity for YLI youth leaders to implement a assessment of the SF Youth Commission that may include surveys, focus groups or interviews and contingent on SF Youth Commissioners vote on Monday, October 16<sup>th</sup> at 5:15pm.

We firmly believe in the youth-led model, strategies and success of YLI in addressing health inequity. YLI has demonstrated the ability to implement evidence-driven policy or systems change and has expertise in applying in community led policy or systems change that address health equity and social determinants of health.

2	Resolution supporting the memorialization of comfort women and other atrocities
3	committed by the Japanese Imperial Army during the 2nd World War.
4	WHEREAS, although in 1993 an apology was issued by Japan and a fund was created for the
5	victims, the fund relied on private donors and was never fully accepted by the South Korean
6	government <sup>[1,3]</sup> ; and
7	WHEREAS, in 2015 South Korea and Japan came to an agreement that Japan would make an
8	apology, and a promise of \$8.3 million dollars to a foundation used to care for the victims; however,
9	South Korea agreed to never criticize Japan over the issue again <sup>[1,3]</sup> ; and
10	WHEREAS, the agreement has been criticized by activist groups as they were not consulted
11	enough and many Koreans want the decision reversed <sup>[1,5]</sup> ; and
12	WHEREAS, there were as many as 200,000 women and girls taken from occupied countries
13	such as China, Korea, and the Philippines and used in brothels during World War II by the Japanese
14	military <sup>[1]</sup> ; and
15	WHEREAS, the Japanese Imperial Army committed countless atrocities across the Asian
16	continent ranging from human experimentation by Unit 731 and Unit 100 of the Japanese military to
17 18	massacres in Manila and Nanjing to name a few <sup>[9,10,11,12]</sup> ; and
19	WHEREAS, Tokyo refuses to admit atrocities committed in formerly-occupied countries and the
20	events are not taught in their schools <sup>[8]</sup> ; and
21	WHEREAS, many comfort women survivors have passed away and only 35 South Korean
22	victims are alive today, and many are running out of time for the reparations and apologies they so
23	long seek <sup>[4,5]</sup> ; and
24	WHEREAS, survivors are still haunted by their experiences: "It was my first time and that
25	experience really caused me so much pain I cooked for and prepared the needs of Captain Sakuma

1	in the morning, while at night he would lie beside me and forced me to make love with him. I did not
2	put up any resistance every time he would have sex with me, because I was afraid of being hurt. After
3	he was through, I would go to the [lavatory] and douche myself." -Ma Fe Yabut Santillan, the
4	Philippines <sup>[6]</sup> ; and
5	WHEREAS, the survivors are not only psychologically tormented by their experiences but
6	some were physically harmed like having uteruses removed <sup>[7]</sup> ; and
7	WHEREAS, the statue was created by Californian Steven Whyte <sup>[1]</sup> ; and
8	WHEREAS, the statue depicts three young girls and a grandmother figure <sup>[1]</sup> ; and
9	WHEREAS, it was first unveiled in St. Mary's Square on September 22nd, 2017 <sup>[1]</sup> ; and
10	WHEREAS, San Francisco's sister city Osaka, Japan has threatened to sever ties with San
11	Francisco over the statue, calling the issue "Japan-bashing" and "a one-sided view" <sup>[1,2]</sup> ; and
12	WHEREAS, 40 statues dedicated to the same message of memorializing Japan's wartime sex
13	slaves have been erected in South Korea, and 10 in the United States including Virginia, New Jersey,
14	and Southern California <sup>[1]</sup> ; and now therefore be it
15	RESOLVED, that the threats by San Francisco's sister city Osaka will not deter the San
16	Francisco Youth Commission from standing on the side of truth; and be it further
17 18	RESOLVED, that the San Francisco Youth Commission encourages the Board of Supervisors
19	and Mayor Ed Lee to encourage the Japanese government to recognize all atrocities committed by the
20	Japanese Imperial Army during WWII; and be it further
21	RESOLVED, that the San Francisco Youth Commission stands by the freedom to express
22	oneself including through the use of art; and be it finally
23	RESOLVED, that the San Francisco Youth Commission encourages the Board of Supervisors
24	and the Mayor Ed Lee to encourage the Mayor of Osaka to rethink his threats to sever ties with San
25	Francisco and to resolve this through open dialogue between our sister cities.
