A. [Inform] Our Children Our Families (OCOF) Council Youth Seat Presentation Presenter: Jay Liao, Deputy Director & Alecia Barillas, Administrative Analyst (Document B)

Chair Hylton shares thanks for the presenters and reminders to please keep it to 10 minutes and advises the Youth Commission that there are no official decisions to be made on this item. Veronica Chew (Senior Analyst) Jay Liao, Child-Friendly Designation partnership with UNICEF. Created when the voters of SF passed Prop C, the Children and Families First Initiative, in Nov 2014. The goal is to improve youth outcomes, council leadership is co-chaired by the mayor and sfusd superintendent and includes: 13 dpt heads from the City & County of San Francisco; 13 leaders from SFUSD, and 14 community representatives appointed by the Mayor, including students, parents, and TAY. Our Approach - getting on the same page with equity, to ensure better outcomes for Latinx and black youth. Three-pronged chair strategy - assess fragmented systems to improve coordination, partner with those systems about scalable and sustainable change, shine a light on impactful work, and inform data decision making. They identify, convene, align, connect, and leverage roles to assist with leadership. Their outcome framework was adopted through 19 indicators that track progress with families and youth in San Francisco. There are five goals and 19 different indicators that are seen through an equity lens. They are focusing on ensuring each and every child enters kindergarten ready to learn and mentally ready. Their short term goal of 100% of all ethnic background are ready to learn. In addition, all families are healthy from all ethnic backgrounds.

Outcomes monitoring (Jay) following indicators for the 2 priorities (K Readiness (Children's data network, k-readiness working group), mental wellbeing (training and capacity (Heal sf), trauma-informed systems training, healing and children's health), data warehouse for city spending analysis.

Jay- They are collaborating with the state on data and created a survey. In addition, partnerships with the school district and theory HATCH. Service inventory and citywide spending analysis and SF child and youth Friendly Clty initiatives are projects they are working on.

Veronica, Child Youth Initiative, Officially partnered with UNICEF to bring the Child-Friendly Cities Initiative to SF. The CFCI is based on a child rights framework that values the needs, priorities, and voices of children and young people in local government. SF is one of the first cities to embark on this transformative process. The pathway to CFCI Candidacy is currently in phase 1. This includes with a situational analysis which is a data-gathering analysis and community assessment associated with this first step. Next, the local action plan will include a framework focused on disaster response and recovery. Finally, support youth and community-led projects will submit a candidacy application to UNICEF and if approved the local action plan will be approved

#### Questions:

Commissioner Quick - Thank you and can you speak a bit to the process as a government body to bring different stakeholders, how does the council bring community input specifically youth input as there isn't a large amount of youth?



Jay- Our council is made up of 3 bodies and in terms of youth, there is youth rep and there is one commissioner. Typically meet 3 times a year and have leaders within the school district and community. We can leverage those decisions we previously did not have. We want to gather better dates to support our programs. In terms of application, we are bringing in a couple of fellows to support and lead the work. It is important when talking about youth rights is led by youth. A lot of it is project related but we want to ensure we have enough participation.

Commissioner Santos- What do you expect as the time and capacity and what could the workload look like for the youth elect?

Jay- The council meetings are typically 3 times a year and unsure how they will look in the future. In the past, they were in the afternoon for no more than 1 hour and a half. A low commitment to the council meetings. There will be some amount of review before each meeting. We are still trying to figure out how it will look virtually.

Commissioner Quick- Over the summer committee groups were meeting semi-regularly on how to best uplift the need of youth. A discussion that came up was using the Youth Commission as a resource, is that still something the organization is still interested in pursuing?

Jay- I think that is a great idea and aligns with our direction is having more youth and community engagement. Our past council meetings have been presenting to council on our work but bringing in and elevating youth voices is something we will try to implement.

C. [Inform + Decision] Transit Recovery Program (Future of MUNI)
Presenter: Eric Chan, Community Organizer, SF Transit Riders
(Document C)

Eric- community organizer with SF Transit rider. Will talk about the future of Muni post-pandemic. SF Transit Rider is a nonprofit advocacy organizer warning to make transportation more accessible and equitable. They are on their 10-year mark and have worked on long term funding, extended transfers, supporting free muni for all youth. Lately, it has been 30 x 30 measures which is to travel from one end of the city in 30 minutes. Through outreach 29, 22, and T are the vital bus lines for the project. We are talking about transportation and importance because of climate mitigation and supporting climate efforts. The diagram displays how poor our environment is currently experiencing, especially seen by poor air quality. We see public transportation as a solution for climate issues and promotes safety as you are 60x less likely to die than in a car and more robust transit to prevent fewer accidents and casualties. Some problems with COVID are the massive budget cuts with MFTA, 30 or 40 lines are suspended indefinitely if not solved then will be 500 million in debt. How does transit come back and be more robust? Lately, the conjunction has been going up and will become worse post-pandemic. All that to say we are focusing on transit recovery. We have 4 main points- transit only lines to keep buses out of traffic, new equitable funding, ensuring safe and accessible transit for all, and increased community engagement and decision making.

Temp emergency transit lanes only allow buses for use but the temp ones are the white diamond lines because they are temporary and an experiment. A bunch of have been passed through the emergency declaration so they don't have to outreach. It has been passed in the Mission and various bus lines. We are pushing for these lines to become permanent once transit becomes a full force. We are requesting SFYC to support this letter, We have 40 signatures and will present during Annual Transit Week. Transit is more than going from one place to another but also climate, pedestrian safety, and a city more economically robust. When youth return to in-person learning they should have a system that supports them.

#### Questions

Commissioner Santos- Thank you for presenting and I am not well versed in transportation. My question is based on the TJ committee in which we read an article on transportation policing. Have you considered this especially for black and brown youths safety in a more interpsoern way?

Eric- We supported free muni for youth but COVID. This is a new conversation in which they are figuring out ways to not police. We acknowledge lower income people of color are affected. We need to keep an eye out when it fully returns and how it looks like when we return.

Commissioner Quick- Thank you for presenting. I spoke to a former commissioner and because everything is low intensity right now there is a cost analysis on their fare collection program especially on youth. We are wondering if transit riders are considering the fare committee and asking SFMTA and is this costing you more than collecting?



Jay- That is a good question and havent not made a call for that type of analysis. Fares generate 15-20% of their revenue and wouldn't make sense to spend more than that. What would it look like in being a community ambassador and it goes into out progressive policies.

Commissioner Hylton- request to repeat asks.

Jay- The asks area google form of 5 questions. 1 commissioner submits the form and states you support the organization. If you want to work on more transit-related issues than reach out to us.

Commissioner Hylton opens public comment. No public comment.

Commissioner Hylton asks the commissioners for questions or recommendations.

Commissioner Quick- Repeated the 4 asks and is comfortable with approving them.

# OMNIBUS PRELIMINARY BUDGET PRIORITIES RESOLUTION (2021 SEASON)

Presenter: Calvin Quick, LAO

## BACKGROUND – THE BUDGET PROCESS

- San Francisco operates on a two-year budget cycle.
- The elaboration of Department budgets begins in mid-December. Departments submit their budget requests to the Controller in mid-February.
- The Mayor's Office of Public Policy and Finance consolidates the budget, which is then submitted to the BOS on May I (for enterprise departments) and June I (for the rest of the budget).
- The BOS then considers the budget, makes cuts and add-backs, and enacts it by August 1.

But COVID may garble this entire structure, as it did this year!!!

## **BACKGROUND**

- The Youth Commission presents its Budget and Policy Priorities (BPPs) for youth to the Board of Supervisors (BOS) every year for consideration during the budget process (usually in May).
- However, Youth Commissioners cannot advocate in their official capacity for youth-related programs and funding until they have formally endorsed them, leaving the youth they without a voice early in the budget process.
- Hence in order to start budget advocacy earlier, the Youth Commission needs to have approved an early version of its budget priorities early in each term.

# **OBJECTIVES**

- The Omnibus Preliminary Budget Priorities Resolution (OPBP Resolution) tackles these procedural issues head-on:
  - It enables the Youth Commission, its officers, staff, and its members to advocate early on in the budget process for specific programs.
  - It allows for youth advocacy organizations to influence the budget process through the Youth Commission in a meaningful way right from the beginning.
  - It enables Youth Commissioners to begin the process of reflection on both the abstract and concrete budget and policy priorities of the Commission as a lead up to the BPPs.

## PROCESS - FORMAT

- Resolution format: relatively to-the-point, yet also carries more weight than motions, and is structured to basically be a list of short and pithy demands. The process also enables a deliberative approach while allowing opportunity for plentiful amendments to be presented.
- Begins as a blank sheet: will be progressively filled out.
- Introduced by Legislative Affairs Officer, who will work with staff to prepare all formal amendments designating priorities.

## PROCESS - COMMITTEES

- After first reading, this Resolution is referred to all three policy committees simultaneously.
- Ideal, the policy committees will elaborate their budget priorities over three to four meetings (once staff has hashed out overall timelines for the fall, this will become more tangible):
  - In the initial stage, the committees solicit community and CBO input and discuss what programs that are or could be funded in the budget they want to support or oppose.
  - Committee then list out the actual list of programs in their issue areas that they want to recommend to the full Commission, which will then vote on incorporating them into the resolution.
  - Tentatively, we will have this all finalized by around the end of this year, beginning of next.

## PROCESS - COMMITTEES

A more detailed timeline will be set up once staff has a better idea of how things will pan out this fall.

8	WHEREAS, The City and County of San Francisco ("the City") operates on a two-year
9	budget cycle, with the elaboration of department budgets beginning every year in December
10	with the issuance of budget directions to departments by the Mayor's Office and the
11	Controller's Office, and the final budget being signed in August; and
12	WHEREAS, The Youth Commission is charged by the Charter to present a report on its
13	Budget and Policy Priorities ("BPPs") for youth to the Board of Supervisors ("BOS") every year
14	for consideration during the budget process, usually at a date in the months of April or May;
15	and
16	WHEREAS, The Youth Commission's BPPs consist of recommendations for
17	consideration by the BOS during the budget process, detailing the policy merits of a wide
18	range of programs and policies and making sophisticated recommendations for action by the
19	BOS, both budget-related and policy-oriented; and
20	WHEREAS, However, Youth Commissioners cannot advocate in their official capacity
21	for youth-related programs and funding until they have formally endorsed them; and
22	WHEREAS, The budget has already gone through many iterations by the time the
23	Youth Commission presents its BPPs to the BOS, leaving little room for significant changes
24	based on recommendations made in the BPPs; and
25	

1	WHEREAS, The needs of youth and their communities are therefore easily left out of
2	the elaboration of department budgets and further review before they come before the BOS;
3	and
4	WHEREAS, Additionally, the ongoing COVID-19 public health crisis led to numerous
5	changes to the timeline and format, including the accessibility, of the 2020 budget season,
6	and while the 2021 budget season is currently expected to happen as usual, there is
7	considerable uncertainty as to whether currently unforeseen events may necessitate or
8	otherwise provoke new changes to the budget process; and
9	WHEREAS, Therefore, in order to represent the interests of youth throughout the entire
10	budget process, this Resolution enumerates the youth-related programs that the Youth
11	Commission wishes to see funded in FY 2021-2022 and FY 2022-2023; and
12	WHEREAS, This Resolution enables the Youth Commission to advocate early on in the
13	budget process for certain specific programs that fulfill the needs and requests of the Youth
14	Commission's constituency; and
15	WHEREAS, Furthermore, this Resolution allows for youth advocacy organizations to
16	influence the budget process through the Youth Commission in a meaningful way from the
17	very beginning of the budget process; and
18	WHEREAS, This Resolution has been considered by the three policy committees of the
19	Youth Commission which, in conjunction with the Youth Commission's Executive Committee,
20	have heard from community members and organizations, as well as City departments, and
21	have ensuingly formulated recommendations for various youth-related programs that they
22	wish to see funded in the upcoming budget season; and
