## 2017 APPLICATION FOR SEAT 6 (YOUTH SEAT) ON THE SUGARY DRINKS DISTRIBUTOR TAX ADVISORY COMMITTEE (I.E. "SODA TAX ADVISORY COMMITTEE")

### What is the Soda Tax Advisory Committee?

San Francisco voters passed Proposition V in November 2016, which taxes distributors (sellers) of soda at the rate of 1 cent per ounce. The goal of the tax is to decrease soda consumption, which is linked with health problems like diabetes, and to address health inequities impacting low income communities of color in San Francisco, including and especially young people.

Proposition V also created a 16-member advisory committee to help determine how the funds generated by the new tax should be invested for the betterment of our communities. Seat 6 on the advisory committee is for a young person 19 years old or younger.

### "What is the time commitment? Is the position paid?"

## *The role is currently <u>unpaid</u> and will require a regular commitment of 2-5 hours a month. This includes:*

- 1. 4-6 afterschool meetings a year, starting in August
- 2. Check-ins to prepare and/or debrief with Youth Commission staff, who will provide support to the young person sitting in Seat 6
- 3. Additional training, as needed, to build your leadership skills

# A strong candidate will be a young San Francisco resident age 19 or younger and possess:

- A passion for addressing health inequities impacting low-income communities of color
- Knowledge of or experience with after-school, summer, and youth-focused programs in San Francisco
- Interest in making systems and organizations work well and a desire to see that youth are being served well by City services
- A passion for youth-inclusion in decision making
- Awareness of, and connection to, the diverse experiences of youth in San Francisco
