1. Call to Order and Roll Call for Attendance

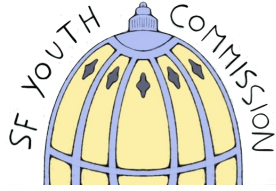
Chair Miller called the meeting to order at **5:40pm**.

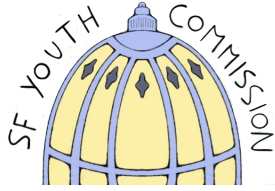
