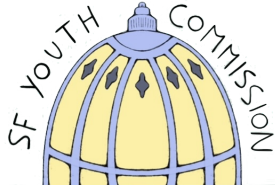
1. Call to Order and Roll Call for Attendance

Chair Miller called the meeting to order at 5:35pm.

2. Communications

Joshua Rudy Ochoa, Community Engagement Specialist of the SFYC, shared communications and meeting announcements with Commissioners.

3. Approval of Agenda (Action Item)

No discussion, and no public comment.

5. Public Comment on matters not on Today's Agenda (2 minutes per comment)

No public comment.

6. HRT Budget & Policy Priorities (discussion & possible action)

Vice Chair Anish joined the meeting at 6:02pm, and was marked as tardy.

Specialist Ochoa outlined the plan for the HRT Committee's budget and policy priorities (BPPs) and the overall Youth Commission's goals for budget advocacy. Commissioners put together draft language for six proposed priorities: (1) Address Youth, TAY, and Family Homelessness and Housing; (2) Expand Youth-Centered Recreational Spaces; (3) Make Transportation Accessible and Equitable for Youth; (4) Achieve Vision Zero; (5) Remove Freeways to Unite Communities; (6) Codify Free MUNI for All Youth.

Commissioner Adair, seconded by Commissioner Nguyen, motioned to extend the meeting until no further business. The motion carried by the following roll call vote:

7. Committee Business (all items to follow are discussion & possible action)

a. School Tripper resolution

Chair Miller asked if there was any feedback from SFMTA staff regarding school trippers, but staff said there was no response. Chair Miller and Vice Chair Anish contacted their appointing officers (Supervisor Preston / Supervisor Melgar), but they have not responded due to the BOS legislative recess. Chair Miller asked for



members for finalized language to be able to push forward to the full Youth Commission for final approval.

b. Freeway Removal resolution

Commissioner Nguyen highlighted the amendments since the first reading of this resolution at the full Youth Commission meeting, especially on the points of concern in regard to crime. Commissioners acknowledged the public comment given at the last meeting. Commissioner Nguyen also pointed out that she'd prefer the resolution focus on completing the study of the removal for the Central Freeway.

Commissioner Adair, seconded by Commissioner Wong, motioned to approve the current language of the Freeway Removal resolution. The motion carried by the following roll call vote:

c. Vision Zero resolution

Commissioner Nguyen discussed the initial beginnings that her and Chair Miller worked on to fulfill the Vision Zero campaign promises. Commissioners discussed that they needed to do further research to input data, and asked staff to contact WalkSF for a potential meeting in committee or offline. Commissioner Nguyen asked staff to request the survey by SFMTA in their 2020-2021 Program Evaluation Highlights, in addition to asking SFMTA what the status update is for traffic calming efforts near schools.

d. Potential Rescheduling of January 23rd Meeting

Commissioners tentatively scheduled a special meeting on Tuesday, January 24th at 6:30pm, or at 5:30pm if there's no scheduling conflicts.



e. HRT-related Updates

Commissioner Nguyen said there's a forum on the removal of the Central Freeway taking place in early March that she'd like Youth Commissioners to get passes to, and staff will be following up with the event's organizers.

8. Staff Report (discussion item)

Specialist Ochoa affirmed his tasks for after this meeting that he'd be putting together meeting and information requests to CBOs and city departments, and ensuring that the HRT Committee's Budget and Policy Proposals are finalized by the next HRT Committee meeting.

9. Announcements (this includes Community Events)

Chair Miller will be sending out an event invitation on google calendar for an upcoming event.

10. Adjournment

There being no further business on the agenda, the Housing, Recreation, & Transit Committee adjourned at 7:32pm.
